#### At the Children's Advocacy Center of

**Benton County,** abused children and their families can receive the support needed to deal with the trauma. We are available to serve all Benton County child abuse victims under age 18 after a report has been made to the child abuse hotline.

#### We provide:

- A child-friendly and nonthreatening environment
- Trained forensic interviewers (bilingual services available)
- Specialized Sexual Assault Nurse Examiner and an on-site medical exam room
- Child advocates to assess family needs and provide follow-up, support, and referral services
- On-site counselors available to meet with the child and non-offending family members
- All services provided at no charge to the family
- Trainings provided at no charge

## **Our Services**

The core of the Children's Advocacy Center model is to minimize trauma by facilitating a multi-disciplinary team approach. From the initial allegation of abuse, children are brought to our center to receive services in a child-friendly and safe facility. Forensic Interviewers give the child

FORENSIC INTERVIEWS

936

Specially trained Forensic Interviewers work with the MDT to ensure victims are not interviewed unnecessarily and allow them to do so in a safe, legally sound and neutral setting.

#### ADVOCACY SERVICES

977

Advocacy focuses on the needs of the child and non-offending caregiver(s) in the aftermath of their crisis and trauma, by providing needed support and information along with a compassionate, listening ear. legally-sound, and neutral setting. Advocates, nurses, counselors, and investigators work together to guide the investigation and treatment to ensure the greatest level of protection and care for the child and his/her family.

#### MEDICAL EXAMINATIONS



Specialized medical evaluations are offered for the purpose of cultivating healing and offering reassurance in order to instill hope in children during times of need.

MENTAL HEALTH

Specialized evidenced based, trauma-focused mental health services sessions are offered to provide quality, holistic counseling services to children and their families by treating the whole child systemically to help them cope with the trauma and to assist them throughout the healing process.




